- Facility was treated on 8/11/2025 and 8/13/2025 by Western Exterminator Company.

- Most recent pest control report was provided.

- Other kitchen spaces, shared areas and hallways were also treated during this service.

- Per PIC, there will be weekly pest control service at this facility for the month of August 2025.(send pest control reports to roy.bwogi@sfdph.org).

- No sign of live vermin activity observed at time of inspection.

Recommendations:

1. Repair the door sweep at the roll up delivery door and/or any other door seeps throughout the facility.

2. Seal all holes,gaps,cracks and crevices throughout the facility.

3.Continue daily monitoring of the facility for any vermin activity and follow the recommendations of the pest control company in combination with maintaining daily clean and sanitary practices throughout the facility.

This facility's Permit to Operate is reinstated and the facility is now allowed to reopen to the public. All violations related to the imminent public health hazards have been corrected. A new placard has been issued.
